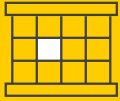

Glossary: InPost International and Additional Services



InPost International service

InPost International	InPost International is a parcel shipping and delivery service from Poland to pick-up points in the following countries: France, the Netherlands, Luxembourg, Belgium, Italy, Spain, and Portugal.
Additional cover	A service available for insured Parcels (as defined in the Terms and Conditions) containing commercial goods or valuable items up to the gross value specified.
Shipment to islands	A service for shipping Parcels to pick-up points located on islands that are territories of the countries covered by the InPost International service. The list of islands currently includes: Corsica, Sardinia, Sicily, Mallorca, Menorca, and Ibiza.
InPost International Fuel Fee	InPost International Fuel Fee is a surcharge applied in international transport, which is added to the basic price of each Parcel.

Additional services

Pick-up service	Pick-up service is a paid courier pick-up when shipping a specified number of parcels (ad-hoc). The service is included in the price if the sender orders the shipment of 5 or more parcels at once, where parcels shipped under the current Terms and Conditions of Paczkomat® 24/7 service are added to any courier shipments and elements of freight shipments sent under the current Terms and Conditions of postal and transport services provided by InPost Sp. z o.o., and to parcels sent under the InPost International service according to the current Terms and Conditions of InPost International services for Business Customers. Pick-up service fees do not apply to subscription agreements, unless the provisions of such agreements provide otherwise.

Glossary: Additional Fees

To avoid extra fees, make sure that you declare correct Parcel size on the label and that the Parcel does not exceed maximum dimensions and weight limits.

Parcel verification after changing the size	A fee is charged when the Parcel's actual size does not match the size declared by the sender. When creating the shipment, remember to select the appropriate Parcel size for the minimum and maximum height and width.
Oversized Parcel handling fee	A fee is charged in two cases: a) for exceeding the maximum permitted Parcel weight (25 kg), or b) for exceeding any of the maximum dimensions for Size C Parcels: 390 x 380 x 640 mm (height x width x length).
Oversized Parcels – larger than 500 x 500 x 800 mm or heavier than 30 kg	A fee is charged in two cases: a) for exceeding the Parcel weight of 30 kg, or b) for exceeding any of the dimensions 500 x 500 x 800 mm (height x width x length).
Return to Sender	In the cases specified in the Terms and Conditions, particularly when the recipient is absent or refuses to accept the Parcel, or when the address is incorrect, the Operator will return the Parcel to the sender's address. The fee for returning the Parcel equals the net fee paid by the sender (plus the applicable VAT rate) and the InPost International Fuel Fee applied, provided that it amounts to the net fee for shipping the Parcel according to its actual weight and dimensions determined by the Operator (plus the applicable VAT rate) in the case of any mismatch between the actual weight and dimensions and the weight and dimensions declared by the Customer.
Contractual penalty	The Operator may charge the sender with a contractual penalty, in the amount specified in this Price List, for any breach of the Terms and Conditions of InPost International services for Business Customers.



The Price List is subject to the provisions of the Terms and Conditions of InPost International services for Business Customers in effect as at the Parcel shipping date, particularly with regard to the terms used in the Price List and the services provided. This Price List (as considered separately and not explicitly linked to any other InPost offers) does not constitute an offer within the meaning of the Polish Civil Code.
